PROCEDURAL ORDER RE: SCHEDULE PROPOSALS

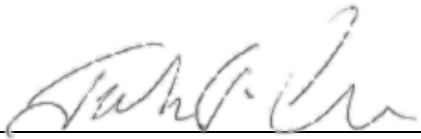
On August 24, 2017, the Public Utility Commission (“Commission” or “PUC”) issued an order approving certain amendments to Georgia Mountain Community Wind, LLC’s (“GMCW”) winter operating protocol. As part of that order, the Commission directed the parties to file scheduling proposals no later than two weeks from the date of the order.

Two weeks from the date of the order was September 7, 2017. GMCW filed a proposed schedule on that date but neither the Department of Public Service (“Department”) nor the McLanes filed a proposal. There is also no indication in GMCW’s proposed schedule that either the Department or the McLanes agree with GMCW’s proposal.

The Department and the McLanes shall file proposed schedules no later than close of business on September 18, 2017.

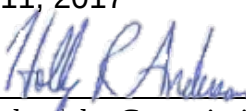
