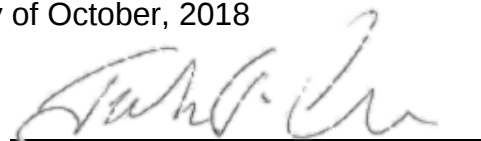
ORDER RE: WITHDRAWAL OF APPEARANCE

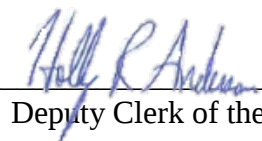
