Status Report Aircraft Detection Lighting System Approval

Dear Ms. Whitney:

This letter serves as a status report concerning Green Mountain Power Corporation's efforts to obtain approval of an Aircraft Detection Lighting System ("ADLS") in order to comply with Condition 34 of the Public Utility Commission's ("Commission") May 31, 2011 Order and Certificate of Public Good in the above-referenced docket.

As explained in the last status report, GMP is investigating the use of technology manufactured by Vestas that will locate equipment on the wind turbines rather than having to build new infrastructure. The radar equipment will be fixed to turbine 10, turbine 21, and a third radar located at an offsite cellular tower.

Since GMP's last status report, we have the following progress to report:

1. GMP has received approval from AT&T for the technical design and specifications that will permit the Company to utilize the three-radar solution and products manufactured by Vestas.
2. GMP is currently negotiating with AT&T to formalize the long-term lease arrangement for the co-location of the Vestas radar on an AT&T cell tower.

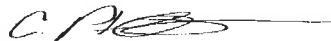

3. After approval from AT&T, Vestas has now begun the work to finalize the supporting documentation required to amend GMP's FAA permits. This includes finalizing the engineering and design for a turbine radar mount that can withstand the frequent harsh weather conditions on top of Lowell Mountain.

Once the Vestas documentation is complete, GMP will submit it to the FAA, seeking permit amendment approval. While the FAA is considering the request to amend the Company's permits, GMP expects to continue its consultation with the Agency of Natural Resources, and will engage with the Department of Public Service concerning the project before making the appropriate filing with the Commission to obtain approval for the ADLS.
