On July 21, 2021, Georgia Mountain Community Wind, LLC (“GMCW”) filed its annual report detailing the results of its winter operating protocol for the winter of 2020-2021 pursuant to the requirements of the Commission’s order in this case dated August 24, 2017.

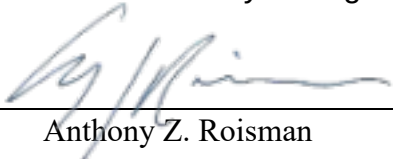
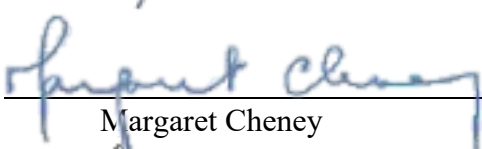
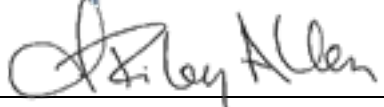
However, our order of August 24, 2017, requires GMCW to file its annual report no later than July 1 of each year for a period of five years.¹ Therefore, GMCW’s recent filing was approximately three weeks late. GMCW did not include any explanation for the lateness of its filing.

The Commission expects GMCW to meet all of its ongoing compliance obligations in this case in a timely fashion.

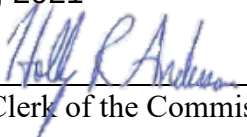
