MEMORANDUM

Re: Accidental Deletion of Documents in ePUC
Date: September 7, 2022

Earlier today while trying to fix an issue with the “test case” in ePUC, I accidentally deleted all the documents in the above-referenced case in ePUC. While ePUC is backed up, the entire database would need to be restored to recover the documents from this one case. As a result, I am asking the parties to email the clerk the documents they have filed in this case so Commission staff can reupload them into the case with their original filing dates. If a party does not have a copy of a document it filed, it can check if another party has a copy of that filing. If no party has a copy of a filing, we will go through the process of retrieving it from our backup. For your convenience, a copy of the Case Log listing all the documents that have been filed in the case is attached to this memorandum.

To help minimize confusion, the document titles for all reuploaded documents will include the words “reuploaded version.” The documents will be listed again in the Case Log and all parties and subscribers will receive the usual email notifications when the documents are uploaded. Because document titles appear in the email notifications, parties and subscribers will be able to readily identify that the notification is for a reuploaded document.
