ORDER REJECTING AMENDMENT TO DECOMMISSIONING FUND LETTER OF CREDIT

On May 31, 2011, the Vermont Public Utility Commission (“Commission”) issued an order and certificate of public good (“CPG”) in Case No. 7628 approving, subject to certain conditions, the construction and operation of an electric generation facility (the “Project”) by Green Mountain Power Corporation (“CPG Holder”).¹ The CPG included conditions requiring the CPG Holder to file for Commission review and approval a letter of credit.²

On January 31, 2023, Key Bank filed with the Commission an amendment to the previous letter of credit to increase the amount to \$8,784,891.

Having reviewed the amendment to the letter of credit, we find that it does not comply with our requirements regarding letters of credit. The CPG Holder or Key Bank must submit a new amendment to the letter of credit that addresses these deficiencies:

- The amendment to the letter of credit does not have the appropriate case reference number; and
- The amendment to the letter of credit misstates the proper name of the Commission (“Vermont Public Utility Commission”).

The CPG Holder and Key Bank are encouraged to consult the Commission’s website (<https://puc.vermont.gov/electric/letter-of-credit>) where information about filing a letter of credit is posted, including a sample letter of credit and drawing certificate.

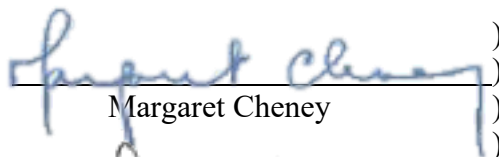
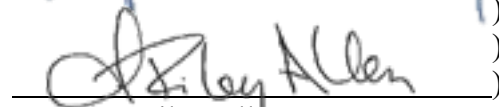
The amendment to the letter of credit filed on January 31, 2023, is rejected. Please file a revised amendment to the letter of credit by April 14, 2023.

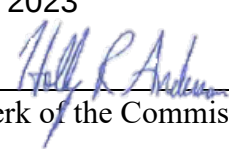
