We hereby issue our Irrevocable Standby Letter of Credit No. 20010326, in favor of Vermont Public Utility Commission, hereinafter referred to as "Beneficiary", at the request of Green Mountain Power Corporation, hereinafter referred to as "Applicant", in an amount not to exceed in the aggregate Eight Million Seven Hundred Eighty-Four Thousand Eight Hundred Ninety-One and 00/100 (\$8,784,891.00) U.S. Dollars.

Funds are available by your draft on us at sight in the form attached hereto as Exhibit A, and accompanied by the following documents:

1. This original Letter of Credit and any amendments thereto.
2. A Draw Certificate purportedly signed by officer/representative of Beneficiary in the form attached hereto as Exhibit B.

It is a condition of this Letter of Credit that it will be extended automatically, without amendment, for additional periods of one (1) year from the present or each future expiration date, unless at least sixty (60) days prior to the then current expiration date, we notify you in writing by overnight courier, at the above address, that we elect not to renew this Letter of Credit for said additional period.

Issuer has been requested to issue this Letter of Credit in connection with Condition No. 13 of the Certificate of Public Good ("CPG") issued by the Vermont Public Service Board to Green Mountain Power Corporation on May 31, 2011 in Docket 7628, which has been re-assigned, with Case No. 20-1951-PET. Said Condition No. 13 deals with the establishment of a Decommissioning Plan for the Kingdom Community Wind Farm in Lowell, Vermont. However, Issuer assumes no obligations under the CPG or responsibility or duties thereunder.

We hereby agree that draft(s) drawn under and in compliance with the terms of this Letter of Credit will be duly honored upon receipt of documents as specified above, which may be presented in person or sent via overnight courier at our office located at 6000 Atrium Way, Mt. Laurel, NJ 08054 on or before the expiration date noted above or any automatically extended date as provided herein.

If we receive your Drawing Certificate and the original of this Letter of Credit at such office on any Business Day, all in reasonable conformity with the terms and conditions of this Letter of Credit, we will honor the same by making payment in accordance with your payment instructions on the third succeeding Business Day after presentation so long as the amount of the drawing, together with all previous drawings honored pursuant to this Letter of Credit, does not exceed the aggregate amount of this Letter of Credit. Typographical errors other than in amounts will not violate the conformity provision in this paragraph. If a drawing fails to conform to the terms and conditions of this Letter of Credit it shall not (i) preclude the Beneficiary from correcting any such errors and resubmitting the request nor (ii) act as a waiver of any rights the Beneficiary has under this Letter of Credit.
