**PROCEDURAL ORDER EXTENDING COMMENT DEADLINE FOR THE VERMONT DEPARTMENT OF
PUBLIC SERVICE UNDER 30 V.S.A. § 231**

On October 4, 2018, Salisbury AD 1, LLC ("Salisbury AD 1"), filed with the Vermont Public Utility Commission ("Commission") a motion to transfer the Section 248 certificate of public good ("CPG") issued to Lincoln Renewable Gas, LLC in Docket 8596 to Salisbury AD 1, a motion to amend the CPG, and a petition under 30 V.S.A. § 231 for a CPG for Salisbury AD 1 to own and operate a renewable natural gas facility and for de minimis regulation.

On October 22, 2018, the Vermont Department of Public Service ("Department") filed a motion for an extension of the comment deadline to October 31, 2018.

On October 23, 2018, the Vermont Agency of Natural Resources joined the Department's motion.

The Department represents that Salisbury AD 1 and Lincoln Renewable Natural Gas, LLC, have no objections to the requested extension.

Accordingly, I grant the Department's and ANR's request for an extension to file Section 231 recommendations and comments on the proposed CPG transfer and CPG amendment by October 31, 2108.
