NOTICE PURSUANT TO 30 V.S.A. SECTION 248(j)(2)
PUC Case No. 18-3449-PET

You are hereby notified that Salisbury AD 1, LLC (“Salisbury AD 1”) has filed a petition with the Vermont Public Utility Commission (“Commission”) to amend a certificate of public good (“CPG”) authorizing construction and operation of a renewable natural gas facility at 592 Shard Villa Road in Salisbury, Vermont (the “Project”).

A CPG for the Project was granted to Lincoln Renewable Natural Gas, LLC (“Lincoln RNG”) on April 8, 2016, pursuant to 30 V.S.A. § 248(j). The Project was not constructed, and Lincoln RNG and Salisbury AD 1 have jointly filed a motion to transfer the Section 248 CPG to Salisbury AD 1. Concurrent with the proposed CPG transfer, Salisbury AD 1 proposes modifications to the facility that require an amended CPG.

The proposed modifications consist of changes in the physical layout, equipment selection, and feedstock for the Project. The Project will occupy a similar footprint at the Project site, but in a slightly different location and configuration. The proposed changes in feedstock for the facility will require changes in the equipment and materials handling areas. More detailed information is available in the petition, which can be accessed using the above case number in the Commission’s online document management system, known as ePUC, at <https://epuc.vermont.gov>. Information on how to participate in the case through public comment or intervention can be found at www.puc.vermont.gov/document/section-248j-procedures.

The Commission has determined that the amendment request will proceed under 30 V.S.A. § 248(j), the Commission’s procedure for permitting facilities of limited size and scope, consistent with the procedure used to grant the CPG for the Project. **Persons wishing to submit comments**, including as to whether the petition raises a significant issue with respect to the substantive criteria of 30 V.S.A. Section 248, or whether the petition qualifies for processing under subsection 248(j), **must file their comments with the Commission on or before January 4, 2019**. Comments may be filed online using ePUC or mailed to the Commission at the above address. Members of the public may also email comments to the Commission at puc.clerk@vermont.gov. If no comments raising substantive issues are received, the Commission may grant a CPG without a hearing.
