ORDER MODIFYING SCHEDULE

This case involves an investigation, pursuant to 30 V.S.A. § 30, into the compliance of Telephone Operating Company of Vermont, Inc., doing business as Consolidated Communications, Inc. (“Consolidated”), with service quality standards for retail customers of telecommunications services. In this Order, we adopt a schedule for the remainder of this proceeding.

On May 16, 2019, we conducted a status conference in this proceeding. During the status conference the parties in this case stated that they would file a joint procedural schedule, or separate procedural schedules, for the remainder of this proceeding by May 30, 2019.

On May 30, 2019, the Vermont Department of Public Service (“Department”) filed a proposed procedural schedule. The Department also states that Consolidated does not object to the proposed procedural schedule.




Accordingly, we adopt the following procedural schedule for the remainder of this proceeding:
