ORDER GRANTING SECOND EXTENSION OF TARIFF FILING DEADLINE

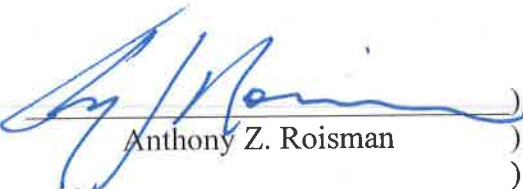
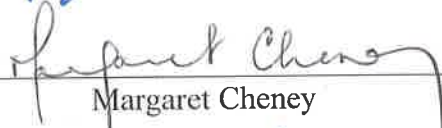
On December 19, 2019, the Vermont Public Utility Commission (“Commission”) issued an order in this case approving, subject to conditions, certain rate design changes proposed by Washington Electric Cooperative, Inc. (“WEC”). In that order, the Commission directed WEC to file tariffs in compliance with the order within seven days. On December 23, 2019, the Commission granted an extension of the deadline for this filing to January 17, 2020.

On January 9, 2020, WEC filed a motion requesting a second extension of the deadline for filing compliance tariffs. WEC requested that the deadline be extended to 10 days after the Commission issues a final order in Case No. 19-4576-TF which concerns an ongoing investigation into WEC’s proposed rate adjustments. WEC states that it is appropriate to implement the rate design after there is certainty regarding the underlying rates. The Department supports WEC’s requested extension.

Based on WEC’s representations, its motion is granted. The compliance tariffs required by the Commission’s December 19, 2019, order in this matter shall be filed within 10 days after the Commission issues a final order in Case. No. 19-4576-TF.

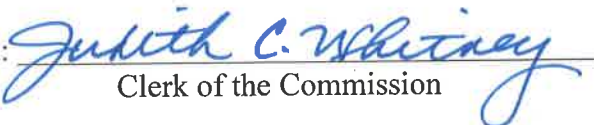
