PROPRIETARY AND COMMERCIAL SENSITIVE INFORMATION**



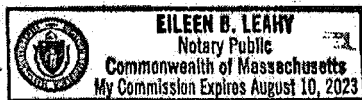
