PROCEDURAL ORDER SCHEDULING A REMOTE EVIDENTIARY HEARING

This case involves joint petition filed with the Vermont Public Utility Commission (“Commission”) by Southern Vermont Cable Company (“SVCC”), a Vermont corporation, and Comcast of Connecticut/Georgia/Massachusetts/New Hampshire/New York/North Carolina/Virginia/Vermont, LLC, doing business as Comcast (“Comcast”), a Delaware limited liability company for approval for SVCC to sell its Vermont cable television system assets to Comcast.

The evidentiary hearing in this case will be conducted remotely on Friday, April 3, 2020. At the March 23 status conference, all parties agreed to hold the hearings remotely using either a telephone conference number or a web-based online platform.

The evidentiary hearing will begin at 9:30 a.m. on Friday, April 3, 2020, via GoToMeeting. At the beginning of the hearing, I will provide a brief overview of remote hearing procedures, attempt to resolve any technical issues, and address any other administrative matters.

The parties should file the following documents in ePUC by Thursday, April 2, 2020, at 5:00 p.m.:

- A stipulated joint list of all prefiled testimony and exhibits for which there is no objection. The stipulated joint list should be filed as an exhibit and all referenced exhibits will be pre-admitted as a group at the evidentiary hearing so that the parties will not have to individually identify exhibits and prefiled testimony for admission at the evidentiary hearing.
- A joint schedule of witnesses required for cross-examination and an estimate of cross-examination time for each required witness. Labeled cross exhibits, if any, should be emailed to all other parties and the hearing officer (micah.howe@vermont.gov) by the same time.

Representatives should ensure that witnesses have access to a copy of their testimony and exhibits during the hearing.
