Pursuant to the Protective Agreement filed with the Vermont Public Utility Commission ("Commission") on February 13, 2020 ("Protective Agreement"), and subject to the Protective Order entered on March 9, 2020 (the "Protective Order"), Comcast of Connecticut/Georgia/Massachusetts/New Hampshire/New York/North Carolina/ Virginia/ Vermont, LLC ("Comcast") submits this Averment and seeks confidential treatment for information Comcast is required to file with the Vermont Public Utility Commission ("Commission") and the Department of Public Service ("Department"). Specifically, this Averment relates to the detailed migration plan required

by Condition 34 of the Certificate of Public Good issued in Case No. 19-4845. The detailed migration plan contains proprietary and commercially sensitive information regarding the migration of Southern Vermont Cable Company ("SVCC") customers from SVCC services and billing to Comcast services and billing. The information required by the Protective Agreement and the Protective Order in this case follows.
