


PROCEDURAL ORDER

On October 15, 2021, MHG Solar LLC (“Applicant”) filed a letter titled “Richville Road Response to PUC.” Though this filing was not submitted as a motion, the substance of the filing is a request for reconsideration of the Vermont Public Utility Commission’s September 17, 2021, Order denying the Applicant’s petition for a certificate of public good.¹ Parties may file a response to the filing by no later than November 5, 2021.

SO ORDERED.


