PROCEDURAL ORDER SETTING COMMENT DEADLINE

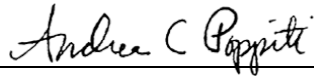
On April 7, 2022, Salisbury AD 1, LLC (“SAD 1”) filed a petition with the Vermont Public Utility Commission (“Commission”) to amend the Certificate of Public Good (“CPG”) previously issued for SAD1’s Salisbury Renewable Natural Gas Facility (the “Project”) in Docket No. 8596 and as amended in Case No. 18-3449-PET. SAD1 requests that the Commission modify Condition 7 of the Amended CPG to allow for occasional deliveries outside of the approved feedstock delivery schedule. Specifically, SAD 1 requests that Condition 7 of the CPG be revised as follows:

The CPG Holder shall restrict off-farm feedstock deliveries to the Amended Project to the hours between 8:00 A.M. and 5:00 P.M. Monday through Friday, and 9:00 A.M. to 1:00 P.M. on Saturday, except that up to 10% of weekly deliveries may be made between the hours of 5:00 AM and 8:00 PM on any day of the week.

Comments on the proposed revision to Condition 7 are due to be filed by May 20, 2022. Reply comments should be filed by no later than May 27, 2022.
