**VERMONT GAS SYSTEMS, INC.’S REVISED REQUEST
FOR APPROVAL OF PROCEDURAL SCHEDULE**

A scheduling conference was held in this matter on July 21, 2022 during which the Hearing Officer for the Vermont Public Utility Commission (the “Commission”) ordered the parties to submit a revised scheduling proposal that would accommodate an earlier evidentiary hearing. Consistent with the issues discussed at the scheduling conference, Vermont Gas Systems, Inc. (“VGS”) hereby submits the following proposed schedule. As with the prior proposal, the initial stage of this schedule contemplates discovery and an opportunity for the Department of Public Service (“Department”) to review and develop a proposed recommendation. At the end of this stage, the parties may recommend that the Commission take the matter under advisement or proceed with an evidentiary hearing pursuant to the Evidentiary Hearing Track identified below.
