Pursuant to the Scheduling Order issued by the Vermont Public Service Board ("Board") on August 5, 2016, Board staff will conduct a workshop commencing at 9:30 A.M. on Thursday, September 22, 2016, in the Susan M. Hudson Hearing Room, Third Floor, People's United Bank Building, 112 State Street, Montpelier, Vermont.

The purpose of the workshop is to allow participants to present and discuss: (1) proposed resource-acquisition modeling proposals, including modeling assumptions, quantifiable performance indicator ("QPI") and minimum performance requirement ("MPR") frameworks, optimization targets, and estimated rate and bill impacts; and (2) the Vermont Department of Public Service thermal-energy-and-process-fuels ("TEPF") forecast proposal. The workshop will be recorded by a court reporter.
