MEMORANDUM

Re: Department of Public Service Request for Extension
Date: September 27, 2016

On August 5, 2016, the Vermont Public Service Board ("Board") issued a Scheduling Order in this proceeding that established a deadline of September 30, 2016, for participants to file comments on scenario modeling proposals and the thermal energy and process fuels ("TEPF") forecast proposal. At the September 22, 2016, workshop the Vermont Department of Public Service ("Department") requested an extension of time, until October 3, 2016, to file its comments. No workshop participant objected to the Department's request.

In the August 5 Order, the Board designated Thomas Knauer, Utilities Analyst, as the lead Board staff for this proceeding, with authority pursuant to Board Rule 2.215(C) to make modifications to the schedule as appropriate. Mr. Knauer has asked me to inform you that the request for an extension of the comment deadline is granted. The deadline for all participants to file comments on scenario modeling proposals and the TEPF forecast proposal shall be October 3, 2016.
