PREHEARING CONFERENCE MEMORANDUM

I convened a Prehearing Conference on October 6, 2015. The following appearances were entered: Leslie Caldwell, Esq., Legal Counselors & Advocates PLC for David Blittersdorf; and Geoffrey Commons, Esq., and Aaron Kisicki, Esq., for the Vermont Department of Public Service ("Department"). Two members of the Town of Irasburg Selectboard, Robin Kay and Brian Sanville, also participated and indicated that the Selectboard intended to intervene.

The primary issue was the establishment of a schedule for the proceedings. Counsel for the Department recommended that before setting a schedule for discovery and testimony, the Vermont Public Service Board ("Board") first determine the parties. No party objected to this proposal. Accordingly, I adopted the following schedule:


October 20	Deadline for Intervention Requests
October 30	Deadline for Responses

Following receipt of any intervention requests and a ruling on them, I will solicit proposals for a schedule governing the remainder of the proceeding. I have tentatively set November 12, 2015, at 2:00 P.M., for a status conference by telephone to discuss such proposals and adopt a schedule. This may be changed (or converted to a request for written filings) based upon the number of persons or entities ultimately granted party status.

The participants at the Prehearing Conference also proposed that they be permitted to make filings electronically, with paper copies to follow. The electronic filing date would be treated as the time of filing if it precedes receipt of the paper filing with the Board. I accepted this proposal.
