STIPULATED PROPOSED AMENDED SCHEDULING ORDER

NOW COMES Petitioner and with the consent and stipulation of the Town of Manchester and Department of Public Service file this proposed schedule for the remainder of this matter. Though all parties agreed to the previous Scheduling Order, entered by this Commission on April 24, 2025, an amendment is now requested to accommodate the parties’ competing needs and interests. Accordingly, the parties now submit the following stipulated schedule for the remainder of this matter:

1. Deadline for discovery to be served on Petitioners by May 15, 2025.
2. Petitioners’ responses to first round of discovery due ~~June 16, 2025~~ **August 1, 2025**.
3. Discovery shall be served on non-Petitioners by ~~June 16, 2025~~ **August 1, 2025**.
4. Non-Petitioners’ responses to discovery due ~~July 15, 2025~~ **September 15, 2025**.
5. The parties shall have until ~~August 29, 2025~~ **October 28, 2025** to complete depositions.
6. The parties shall file pre-filed testimony and exhibits by ~~October 15, 2025~~ **December 15, 2025**.
7. The parties shall file rebuttal pre-filed testimony by ~~November 7, 2025~~ **January 6, 2026**.
8. The parties seek to have a hearing on this matter the week of ~~November 17, 2025~~ **January 26, 2026**. Should any dates within that week become “unavailable” to a party or their witnesses, they shall notify the other parties and the Commission.
9. The parties will discuss and set a schedule for any post-hearing briefing at the hearing.
