**ORDER RE AMENDED SCHEDULE**

This case involves a petition filed by Bell Atlantic Mobile Systems, LLC and Vertex Towers, LLC (the “Petitioners”) on November 1, 2024, for a certificate of public good (“CPG”) under 30 V.S.A. § 248a, with the Vermont Public Utility Commission (“Commission”) authorizing the installation of telecommunications equipment in Manchester, Vermont.

On April 24, 2025, I issued a scheduling order in this case.


On July 9, 2025, the parties submitted a jointly stipulated motion to amend the schedule to accommodate the needs of the parties going forward.

Based upon that submission, I adopt the amended schedule below:

Deadline for discovery to be served on Petitioners	May 15, 2025
Petitioners’ responses to first round of discovery due	August 1, 2025
Deadline for discovery to be served on non-Petitioners	August 1, 2025
Non-Petitioners’ responses to discovery due	September 15, 2025
Deadline for completion of depositions	October 28, 2025
Deadline for filing prefiled testimony and exhibits	December 15, 2025
Deadline for rebuttal prefiled testimony	January 6, 2026
Evidentiary Hearing	Week of January 26, 2026
