PROCEDURAL ORDER GRANTING MOTION TO CHANGE SCHEDULE

On July 11, 2025, VT Real Estate Holdings 2 LLC (“Fair Haven Solar”) filed a motion to change the schedule in the above-captioned proceeding. Fair Haven Solar, along with the Department of Public Service (“Department”), the Agency of Natural Resources (“ANR”), and the Agency of Agriculture, Food and Markets (“AAFM”) requested an extension of time to discuss stipulations with ANR and AAFM because of summer vacation schedules. Fair Haven Solar requested amendment of the current schedule (issued on March 10, 2025) as follows:

The Department, ANR, and AAFM concur with Fair Haven Solar in its request. Mr. Bischoff, an intervenor, did not object to this request.

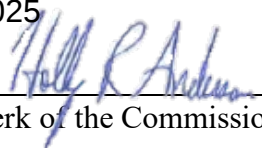
