4. Deadline for non-Petitioners to respond to discovery: January 16, 2025

6. Deadline for completion of depositions: March 2, 2025
7. Deadline for filing non-Petitioner prefiled testimony and exhibits: March 2, 2026
8. Deadline for dispositive motions under Rule 2.219: March 20, 2026
9. Deadline for filing rebuttal pre-filed testimony: March 30, 2026
10. Evidentiary Hearing: April. 2026 (plus live surrebuttal testimony as applicable)
