On October 2, 2025, Williston G Katie Lane Solar, LLC (“Applicant”) requested a certificate of public good, pursuant to 30 V.S.A. §§ 8010 and 248 and Commission Rule 5.100, for the construction and operation of a 2.9 MW solar net-metering system in Williston, Vermont (the proposed “Facility”).

After reviewing the Petition, the prefiled testimony and exhibits, and the prefiled testimony and exhibits filed in Case No. 25-0209-AN, I have determined that additional information is necessary before I can enter an order setting a scheduling conference in this matter. I request that the Petitioner respond to the following requests for information:

1) In Case No. 25-0209-AN, the Petitioner proposed to construct a 2.375 MW solar array. In this matter, the Petitioner proposes to construct a 2.9 MW solar array. The Petitioner has filed direct prefiled testimony that continues to refer to a 2.375 MW solar array. For example, the direct prefiled testimony of Jeremy Owens, addressing the Facility’s aesthetic impact and orderly development of the region, refers to a 2.375 MW facility on page 2. Please review the testimony and exhibits filed in this matter and clarify whether the Facility will have a capacity of 2.9 MW or 2.375 MW.

2) Assuming that the Facility will have a capacity of 2.9 MW, please describe whether and how the Petitioner has notified or will notify the persons who received advance notice of the project in Case No. 25-0209-AN of the changes that the Petitioner has made to the Facility between its advance notice filing and this Petition.

The Petitioner may submit supplemental or revised prefiled testimony and exhibits to respond to these requests for information. I request that the Petitioner respond to these requests for information by October 31, 2025.
