

## **Public Utility Commission and Department of Public Service Application Fee for all In-State Generation Facilities and for Energy Storage Facilities with a Capacity of 100 kW or Greater**

For applications filed on or after July 1, 2019

Title 30, Sections 248b and 248c establish fees to support the roles of the Public Utility Commission, Department of Public Service, and the Agency of Natural Resources in reviewing applications for in-state generation facilities under Sections 248 and 8010 of Title 30. This form only applies to the fees collected to support the regulatory processes conducted by the Public Utility Commission and the Department of Public Service.

A separate application fee form is available for the Agency of Natural Resources.

When applying for Public Utility Commission (PUC) approval of an in-state facility under Sections 8010 and 248, complete this form and provide the original completed form and the fee payment to the Department of Public Service, and a copy of the form to the PUC as part of the application.

### **Application Fee**

There is a \$100 flat fee for any facility eligible to use the net-metering registration form or the net-metering application form. These include:

- Projects with a plant capacity of 50 kW or less
- Rooftop projects
- Hydroelectric projects filing a net metering registration

For all other facilities, the fee is \$5 per kW.

### **Fees for Modification of Facilities**

Any modifications of the following categories of projects must submit a fee of \$25 if a request for modification is submitted to the PUC.

- Projects with a plant capacity of 50 kW or less
- Rooftop projects
- Hydroelectric projects filing a net metering registration

For all other projects, a flat fee of \$100 is required for a request for modification.
