ORDER RE SCHEDULE

This case involves a petition filed by Rising Tide Towers II, LLC and Wireless Partners FN, LLC (“Petitioners”) on February 3, 2025, for a certificate of public good (“CPG”) under 30 V.S.A. § 248a, with the Vermont Public Utility Commission (“Commission”) authorizing the installation of telecommunications equipment in Pownal, Vermont.

On December 10, 2025, the Petitioners filed a motion to change the schedule to accommodate the needs of the parties. The Petitioners state that the Vermont Department of Public Service (“Department”) consents to the motion.

On December 11, 2025, Tanya and Jesse Hart filed a response in support of the motion.

I find the Petitioners’ request to be reasonable, and I adopt the amended schedule below:

Deadline for conducting depositions	January 16, 2026
Deadline for non-Petitioner testimony and exhibits	February 9, 2026
Deadline for Petitioners rebuttal testimony and exhibits	February 23, 2026
Deadline for third-party aesthetics assessment testimony	March 2, 2026
Deadline for discovery on Petitioners’ rebuttal testimony	March 9, 2026
Deadline for responses to discovery on rebuttal testimony	March 20, 2026
Evidentiary hearing	Week of March 30, 2026
