Petition of Northland Solar LLC for a certificate of public good, pursuant to 30 V.S.A. § 248, authorizing the installation and operation of a 4.999 MW solar electric generation facility in Lowell, Vermont

- Second Round Discovery on Petitioner January 9, 2026
- Petitioner response to second round discovery January 23, 2026
- Non-Petitioner testimony March 13, 2026
- Discovery on non-Petitioners March 27, 2026
- Non Petitioners respond to discovery April 10, 2026
- Petitioner's rebuttal testimony April 24, 2026

Additional event dates requested by the Town of Lowell the Intervenors agree with as well:

- Discovery on Petitioner's rebuttal testimony May 1, 2026
- Petitioner responds to discovery on rebuttal testimony by May 8, 2026
- All motions to strike or other prehearing motions by May 22, 2026
- All stipulations and exhibits, and responses to motions to strike, by May 29, 2026
- Evidentiary hearing, with live surrebuttal testimony if required, week of June 15, 2026 (likely 1 day, possibly 2 days--best to reserve 2 days). This week is being asked for so that school will be over and I as selectboard chair will be fully available and is only 2 weeks out from all stipulations and exhibits, and responses to motions to strike.
