ORDER RE AMENDED SCHEDULE

This case involves a petition filed by Bell Atlantic Systems, LLC and The Towers, LLC (the “Petitioners”) on July 29, 2025, for a certificate of public good (“CPG”) under 30 V.S.A. § 248a, with the Vermont Public Utility Commission (“Commission”) authorizing the installation of telecommunications equipment in Marshfield, Vermont.

On October 24, 2025, I issued a scheduling order in this case.

On January 2, 2026, the Vermont Department of Public Service (“Department”) filed a motion to amend the schedule to allow for additional time for a consultant review. The Department states that the other parties to the case consent to the motion.

Based upon that submission, I adopt the amended schedule below:

Deadline for non-Petitioners to respond to discovery	February 27, 2026
Deadline for completion of depositions	March 23, 2026
Deadline for dispositive motions	April 10, 2026
Deadline for prefiled rebuttal testimony	April 20, 2026
Evidentiary hearing	week of April 27, 2026
