ORDER RE SCHEDULE

This case involves a petition filed by Industrial Tower and Wireless, LLC (“Petitioner”) on August 8, 2025, for a certificate of public good (“CPG”) under 30 V.S.A. § 248a, with the Vermont Public Utility Commission (“Commission”) authorizing the installation of telecommunications equipment in Tinmouth, Vermont.

On January 7, 2026, I issued an order directing the parties to submit a joint or separate schedule(s) for the remainder of the proceeding.

On January 23, 2026, the Petitioner, the Town of Tinmouth, and the Vermont Department of Public Service (“Department”) filed a joint schedule with the Commission.

Deadline for motions for summary judgment	July 24, 2026

Deadline for opposition motions for summary judgment	August 24, 2026
Reply memoranda to opposition motions due	September 8, 2026
Parties submit proposed schedules for further process	Two weeks after final decision regarding motions for summary judgment, if contested issues remain

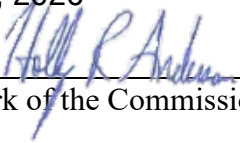
