ORDER RE SCHEDULE

This case involves a petition filed by Rising Tide Towers II, LLC and Wireless Partners FN, LLC (“Petitioners”) on February 3, 2025, for a certificate of public good (“CPG”) under 30 V.S.A. § 248a, with the Vermont Public Utility Commission (“Commission”) authorizing the installation of telecommunications equipment in Pownal, Vermont.


On February 19, 2026, the Petitioners filed a motion to change the schedule to accommodate the needs of the parties. The Petitioners state that the parties consent to the motion.

I find the Petitioners’ request to be reasonable, and I adopt the amended schedule below:

Deadline for third-party aesthetics assessment testimony	March 2, 2026
Deadline for Petitioners rebuttal testimony and exhibits	March 9, 2026
Deadline for discovery on Petitioners’ rebuttal testimony	March 16, 2026
Deadline for responses on all remaining discovery	March 27, 2026
Non-Petitioner’s surrebuttal testimony due	April 6, 2026
Deadline for depositions of third-party aesthetics expert	April 6, 2026
All deposition transcripts due	April 15, 2026
All parties’ primary briefs due	May 1, 2026
All parties’ reply briefs due	May 15, 2026


