ORDER AMENDING SCHEDULE

This case involves a petition filed by Industrial Tower and Wireless, LLC (“Petitioner”) on August 8, 2025, for a certificate of public good (“CPG”) under 30 V.S.A. § 248a, with the Vermont Public Utility Commission (“Commission”) authorizing the installation of telecommunications equipment in Tinnmouth, Vermont.

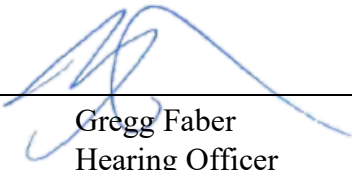

Petitioner response to non-Petitioner discovery	March 17, 2026
Petitioner to file motion for non-substantial change and supplemental prefiled testimony	April 8, 2026
Non-Petitioner response to motion for non-substantial change	April 21, 2026
Petitioner reply to response to motion for non-substantial change	May 13, 2026
Parties submit proposed schedules for further process	7 days after issuance of order on motion for non-substantial change, if contested issues remain
