MEMORANDUM

To: Green Mountain Power Corporation

Re: 26-0651-PET – Notice of Complete Petition
Date: April 21, 2026

On April 8, 2026, the Vermont Public Utility Commission (“Commission”) received your petition to rebuild the Georgia Substation located in Georgia, Vermont.

Commission staff have determined that your petition is administratively complete. **Your case number is 26-0651-PET.**

With the exception of those state agencies that will receive notice of and access to your petition via ePUC, within 2 business days of this memorandum you must provide: (1) a copy of your petition pursuant to 30 V.S.A. § 248(a)(4)(C) and Commission Rule 5.407(A) to all entities and persons entitled to receive such copies, and (2) notice of your petition as required by Commission Rule 5.407(B) and (C).

You must provide the case number when you provide copies and notice of the petition, as well as information on how members of the public may participate in this case. The notice must include, at a minimum, the case number if the case is filed in ePUC, a general description of the type and approximate location of the facilities and upgrades proposed, a statement that a complete petition has been filed with the Commission and that the case has been opened, and information and a link that will allow the recipient to access the complete petition electronically. The notice must also include instructions on how a recipient can contact the petitioner to obtain a hard copy of the complete project plans and petition if the recipient is not able to access them electronically. The notice must include the following links to documents on the Commission’s website:
