On February 28, 2023, the Hearing Officer issued his proposal for decision in this case.

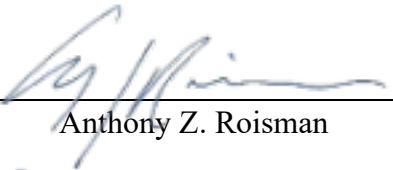
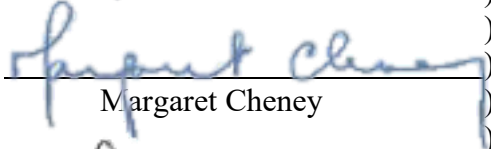
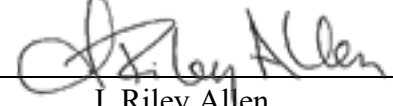
