ORDER GRANTING TOWN’S MOTION FOR INTERLOCUTORY REVIEW




On March 9, 2018, Chelsea Solar LLC (“Chelsea”) filed a brief in support of its proposed schedule in this proceeding in which it argued that it has a vested right to a review of the petition in this case under the Bennington Town Plan in effect in 2014 because the petition in this case is a reconsideration of the petition in Docket 8302, which was filed on June 19, 2014.¹ On May 17, 2018, the hearing officer issued an order in this proceeding ruling that Chelsea has a vested right to the laws that were in effect at the time the first complete Chelsea petition was filed, June 19, 2014. On May 23, 2018, the Town of Bennington (“Town”) filed a motion for leave to take interlocutory appeal of the hearing officer’s May 17, 2018, Order (the “Town’s Motion”). On June 7, 2018, Chelsea and the Vermont Department of Public Service each filed responses stating that they did not object to the Town’s Motion. By this Order, we grant the Town’s Motion.

The parties shall have leave to file simultaneous legal briefs on the May 17, 2018, by no later than July 6, 2018, and simultaneous reply briefs by no later than July 20, 2018.
