ORDER GRANTING DEPARTMENT REQUEST FOR EXTENSION

On July 24, 2018, I issued an order staying this proceeding until 14 days after the issuance of the final decision in Vermont Supreme Court Case No. 2018-120, at which time the parties were to file recommendations on next steps in this investigation, including if necessary, proposed schedules for moving this matter to its conclusion.

On April 26, 2019, the Vermont Supreme Court issued its order in Case No. 2018-120, making the deadline for the parties' recommendations under the July 24, 2018, procedural order May 10, 2019.

On May 7, 2019, the Vermont Department of Public Service ("Department") filed a motion to extend the May 10 deadline to May 31, 2019.¹ The Department represents that no other party has an objection to its request.

Based on the Department's motion and representation, the deadline for the parties to file their recommendations is extended until May 31, 2019.

¹ The Department filed its motion in hard copy. The parties are reminded that this case is being processed using the Commission's online filing and case management system, ePUC. Therefore, all future filings should be made using ePUC. The Clerk's office has scanned the Department's motion into this case in ePUC.


