for approval of its 2020 Integrated Resource Plan

THE DEPARTMENT OF PUBLIC SERVICE AND STOWE ELECTRIC DEPARTMENT'S JOINTLY PROPOSED SCHEDULE

On November 24, 2020, the Town of Stowe Electric Department ("Petitioner") filed for approval of its 2020 Integrated Resource Plan, pursuant to 30 V.S.A. § 218c.

On February 16, 2021, a scheduling conference was held in this matter where the Hearing Officer requested a joint proposed schedule between the Petitioner and the Department of Public Service (the "Department"), including two potential workshop dates and a date certain for issuance of notice of this proceeding to the Petitioner's customers.

The Department and the Petitioner have agreed to a short, on-bill notice to the Petitioner's customers that will be transmitted by mail for customers receiving hard copy bills and by email for customers receiving electronic bills on two billing dates, February 22, 2021, and March 8, 2021. The two billing dates will jointly encompass direct notice to all customers. The on-bill notice will notify the customers of the pending IRP filing with (i) a call for public comment with the Public Utility Commission (the "Commission"), and (ii) a digital link to the Petitioner's webpage that will display further detail and information regarding this proceeding. The Petitioner's webpage will include a notice displaying a link to the Petitioner's proposed IRP, a link to the above-entitled ePUC docket, the adopted schedule in this proceeding, and the Commission Clerk's contact information for assistance with navigating the ePUC's online portal. The Petitioner will separately file the proposed, revised customer notice with the Commission.
