Re: Due dates for comments in response to the July 27, 2021, workshop on SHEI issues

Date: July 27, 2021

On July 27, 2021, a workshop was held to discuss potential changes to Vermont Public Utility Commission (“Commission”) Rule 5.100, the Net-Metering Rule, intended to address issues related to the Sheffield Highgate Export Interface (“SHEI”). A copy of the meeting agenda and PowerPoint, and a transcript of the workshop will be made available through ePUC.¹

Written comments, including proposed rule language, addressing the issues discussed at the workshop may be filed by August 27, 2021. Reply comments may be filed by September 17, 2021. Comments should focus on how the Net-Metering Rule could address the issues posed by the SHEI as well as issues that could potentially arise in other areas of the state due to export or transmission constraints.

Participants are reminded that additional workshops in this proceeding are scheduled for August 24, 2021 (via GoToMeeting) and on September 16, 2021 (in-person at the Commission’s offices). For more information about upcoming workshops, please see the Commission’s order dated July 1, 2021.²
