THIRD AMENDED ORDER RE: SCHEDULE

This case involves an application filed with the Vermont Public Utility Commission (“Commission”) by Norwich Upper Loveland Solar, LLC (“Applicant”) for a certificate of public good (“CPG”) to construct and operate a 500 kW solar electric generation project in Norwich, Vermont (the proposed “Project”).

On March 3, 2023, I issued a second scheduling order in this case setting April 10, 2023, as the date for the evidentiary hearing.

On March 10, 2023, Intervenors Dan and Jenn Goulet, Samin Kim and Jayoung Joo, Stephen Gorman, John and Heather Benson, Laurence and Shelley Ufford, and Joy Kenseth filed a stipulated amended motion to reschedule the evidentiary hearing to either April 21 or April 28, 2023. The Intervenors represent in their motion that both the Applicant and the Vermont Department of Public Service agree to the proposed dates.


In light of the parties’ agreement, the Intervenors’ stipulated motion is granted and the date of the evidentiary hearing in this case is rescheduled to April 28, 2023. I have adjusted the briefing deadlines in the schedule below to reflect the new hearing date.

March 23, 2023	Deadline for discovery served on non-Applicants re: rebuttal testimony
April 6, 2023	Deadline for non-Applicants to respond to discovery
April 28, 2023	Technical Hearing (if needed) at 9:30 A.M.
May 15, 2023	Proposed Findings and Briefs Due
May 29, 2023	Reply Briefs

Please note that the Commission’s revised procedural rules (Commission Rule 2.000) took effect on January 18, 2023, and now apply to this case. Under Rule 2.216(D), objections to the admission of prefiled testimony and exhibits must now be filed no later than 14 days before the date of the evidentiary hearing. Commission Rule 2.107 allows a party to request a waiver of the application of a portion of the new Commission Rule 2.000 to this case.
