PROCEDURAL ORDER AMENDING SCHEDULE

On April 6, 2016, the Department of Public Service (“Department”) filed a motion requesting that I amend the schedule in this proceeding. Under the current schedule, established by an Order dated December 8, 2016, the parties were required to file a stipulation or a proposed schedule for the remainder of the proceeding by April 6. The Department’s motion states that the parties have been engaged in discussions that might lead to a stipulation or other negotiated outcome and indicates that these discussions are ongoing. To enable further discussions, the Department asks that I grant a three-week extension of time, until Wednesday, April 27, 2016, for parties to file a stipulation or proposed schedule. The Department states that it has discussed the proposed amendment with other parties and that it is authorized to represent that Mr. Blittersdorf and Dr. Holland (on behalf of the Town of Irasburg) do not object.

I find the Department’s proposed amendment to be reasonable and grant it. The deadline for parties to file a stipulation or a proposed schedule for the remainder of the proceeding is extended until April 27, 2016.
