
**SECOND PROCEDURAL ORDER AMENDING SCHEDULE**

On April 26, 2016, David Blittersdorf, the owner of the meteorological tower at issue in this proceeding, filed a motion requesting that I amend the schedule in this proceeding. Mr. Blittersdorf's motion states that the parties have been engaged in discussions that might lead to a stipulation or other negotiated outcome and indicates that these discussions are ongoing. To enable further discussions, Mr. Blittersdorf asks that I grant a further extension of time, from the present deadline of Wednesday, April 27, 2016, to June 8, 2016, for parties to file a stipulation or proposed schedule. Mr. Blittersdorf states that he has discussed the proposed amendment with other parties and that he is authorized to represent that the Vermont Department of Public Service, the Vermont Agency of Natural Resources, and the Town of Irasburg do not object to the request.

I find Mr. Blittersdorf's proposed amendment to be reasonable and grant it. The deadline for parties to file a stipulation or a proposed schedule for the remainder of the proceeding is extended until June 8, 2016.
