PROCEDURAL ORDER EXTENDING BRIEFING DEADLINE

This case involves a petition filed by Green Mountain Power Corporation (“GMP”) with the Vermont Public Utility Commission (“Commission”), pursuant to 30 V.S.A. § 218d and Section IV(A)(6) of GMP’s current multi-year rate plan (“MYRP”), for authorization to spend up to \$280 million in additional transmission, distribution, and residential storage investments over the final two years of the MYRP.

On June 25, 2024, the Vermont Department of Public Service (“Department”) filed a motion requesting that the deadline for the parties to file direct briefs be extended from June 28, 2024, to July 1, 2024. The Department does not request any changes to the deadline to file reply briefs, which is currently July 12, 2024. The Department represents that GMP consents to the proposed scheduling change.

Based on the agreement of the parties, the deadline to file direct briefs is extended from June 28, 2024, to July 1, 2024.
